This Month's Program:

January Program – Using Free Remote Controlled HF Receivers.

Richmond native John Drum, W4BXI, now lives in Asheville, NC. It is in a facility that doesn't allow antennas so he has become expert on using remote ham radio stations, including the RARC remote station, W4FJ.

John also makes extensive use of free remote Software Defined Radio-receivers (SDRs) – sometimes called webSDRs – that let him listen to his signal from a remote station or just search for likely "prey" to contact. His presentation at the meeting tells us what he does, what he uses, and where you can find these same remote resources.

If you have a Technician license and wonder whether getting a General license is worthwhile, listening around on the HF bands using a free SDR receiver is a good way to assess that. If you are an active HF user and wonder what your signal sounds like, listening on a free SDR receiver is a good way to find out. If you like casual shortwave listening wherever you are, you can use a webSDR receiver. Whatever your radio interests, knowing how to use webSDRs is useful.

John is an ARRL Life Member, first licensed in Richmond as a Novice with the call sign WN4BXI in 1953. He retired from AT&T.

RARC has the first and only D-STAR digital repeater in the area: 147.255 (+ 600), 443.7125 (+ 5) and 1284.0000 (-20). In addition to our Wednesday local D Star net (below), we link Module C (VHF) to REF 062A for the National Capital Region D Star Net on Wednesday nights at 9pm. On Tuesday nights at 9pm, we link Module C (VHF) to REF 054C for the North Carolina D Star Net.

The RARC D Star Net meets on Wednesday nights at 8:00pm and is accessible on our three D Star modules, all of which will be linked together via REF 062D. So if you are in RF range of the repeater, you can join the net on any of the three RF modules and be heard by everyone.

If you participate in the net via DVAP, DV Dongle or a Hotspot (such as Pi Star), you should link your device to REF 062D rather than to any of our modules which will allow you to be heard by everyone.

Rep. Bill Johnson Introduces Bill to Eliminate Private Land Use Restrictions on Amateur Radio

Congressman Bill Johnson (OH-6) introduced a bill in the U.S. House of Representatives (<u>H.R.9670</u>) on Thursday, December 22, 2022, to eliminate private land use restrictions that prohibit, restrict, or impair the ability of an Amateur Radio Operator from operating and installing amateur station antennas on property subject to the control of the Amateur Radio Operator.

The exponential growth of communities subject to private land use restrictions that prohibit both the operation of Amateur Radio and the installation of amateur station antennas has significantly restricted the growth of the Amateur Radio Service. These restrictions are pervasive in private common interest residential communities such as single-family subdivisions, condominiums, cooperatives, gated communities, master-planned communities, planned unit developments, and communities governed by community associations. The restrictions have particularly impacted the ability of Amateur Radio to fulfill its statutorily mandated duty of serving as a voluntary noncommercial emergency communications service.

Congress in 1996 directed the Federal Communications Commission (FCC) to promulgate regulations (Public Law 104-104, title II, section 207, 110 Stat. 114; 47 U.S.C. 303 note) that have preempted all private land use restrictions applicable

to exterior communications facilities that impair the ability of citizens to receive television broadcast signals, direct broadcast satellite services, or multichannel multipoint distribution services, or to transmit and receive wireless internet services. ARRL attempts to obtain similar relief for Amateur Radio were rejected by the FCC with a statement such relief would have to come from Congress.

ARRL Legislative Advocacy Committee Chairman John Robert Stratton, N5AUS, noted that Congress, in 1994 by Joint Resolution, S.J.Res.90/H.J.Res.199, declared that regulations at all levels of government should facilitate and encourage the effective operation of Amateur Radio from residences as a public benefit. He continued by stating that "H.R.9670, the *Amateur Radio Emergency Preparedness Act*, is intended to fulfill that mandate and preserve the ability of Amateur Radio Operators to continue to serve as a key component of American critical communications infrastructure."

ARRL President Rick Roderick, K5UR, and Mr. Stratton both extended on behalf of the ARRL, its Members, and the Amateur Radio community their thanks and appreciation for the leadership of Rep. Johnson in his tireless efforts to support and protect the rights of all Amateur Radio Operators.
