RARC has the first and only D-STAR digital repeater in the area: 147.255 (+ 600), 443.7125 (+ 5) and 1284.0000 (-20). In addition to our Wednesday local D Star net (below), we link Module C (VHF) on

Tuesday nights at 9pm, to REF 054C for the North Carolina D Star Net.

The RARC D Star Net meets on Wednesday nights at 8:00pm and is accessible on our three D Star modules, all of which will be linked together via REF 097B. So if you are in RF range of the repeater, you can join the net on any of the three RF modules and be heard by everyone.

If you participate in the net via DVAP, DV Dongle or a Hotspot (such as Pi Star), you should link your device to REF 097B rather than to any of our modules which will allow you to be heard by everyone.

# Save our ham bands – Please join ARRL

ARRL membership is expensive at \$59 a year. And if you want the paper version of QST magazine mailed to you, add another \$25. (You can see all the magazines online "free" with a membership.)

So why join? Because no one else stands between our use of the ham bands and all the mobile phone companies looking for more bandwidth, the WiFi nets wanting some UHF and SHF, the stock traders looking for a faster connection using 40-meters, the hedge funds looking to exploit some wireless idea, the government deploying a new technology and on and on.

ARRL has a regulatory staff working with (and sometimes against) the FCC and dealing with congress. They help direct and deploy ham volunteers to Washington, DC. They try to get us to connect with the FCC or our congressional representatives to address the taking of our bands.

"ARRL Urges Protecting the Amateur Radio 902-928 MHz Band – 08/15/2024 - The Federal Communications Commission (FCC) accepted for public comment a Petition for Rulemaking filed by NextNav Inc., a licensee in the 900-MHz Location and Monitoring Service (LMS), to completely reconfigure the 902-928 MHz band and replace the LMS with high-powered 5G cellular and related location services", https://www.arrl.org/news/arrl-urges-protecting-the-amateur-radio-902-928-mhz-band.

To get more leverage, ARRL is a member of the International Amateur Radio Union (IARU) usually in a board or officer position. The IARU works with the International

Telecommunication Union (ITU) on allocating frequencies world-wide.

ARRL provide much more from new product reviews to exam testing services. If you are

into DXing or contesting there is the ARRL Logbook of the World (LoTW), a free service for hams throughout the world. The technical articles in QST and QEX are excellent sources of knowledge and projects.

What it unique about ARRL is the advocacy to protect our bands. And they need our money to do it. That's why you should – in my opinion – join ARRL.

# **D Star Gateway Upgrade**

The W4FJ D Star repeater has been connected to the internet for over 15 years. With crystal clear digital audio, you can make a contact practically anywhere in the world. The ability to link repeaters to reflectors and for users to access D Star repeaters via personal hotspots depends on a "gateway" computer at each repeater site to manage these connections.

Over time, Icom has released new versions of the software that manages the connections. Each time Icom has released new gateway software, a hardware upgrade has generally been required.

Recently, we installed our fourth gateway computer running the latest Icom software. The pictures below show the first gateway (a retired HP commercial grade server, weighing about 80 pounds) and the current mini computer that fits in the palm of your hand. Like everything IT, the hardware gets smaller, faster and cheaper.

Users probably won't notice any change to the way the repeater operates. The upgrade was required by Icom as they moved to a more secure and supported version of the Linux operating system. With our Icom repeater hardware upgrade last year, we are now running the latest Icom hardware and software.

Two reminders: 1) join us for the RARC D Star net on Wednesdays at 8:00 pm; and 2) if you don't have a D Star radio (or digital hotspot) and want to use the repeaters, they all support analog FM. Just set the subaudible tone for 74.4 Hz and the repeaters will switch to analog FM mode.

A huge thank you to Jim Bates, K8OI, who configured all of our gateways and has managed our connectivity since inception.

Identical versions of *The Amateur Radio* Emergency Preparedness Act have been reintroduced in Congress in both the House and the Senate. If passed and signed into law, the legislation would require homeowner associations to

accommodate the needs of FCC-licensed Amateur Radio operators by prohibiting the enforcement of private land use restrictions that ban, prevent, or require the approval of the installation or use of Amateur Radio station antennas. Among other

provisions, this legislation would prohibit homeowner association rules that would preclude or ban Amateur Radio antennas, specify an approval process for installing Amateur Radio antennas, and provide a federal private right of action to Amateur Radio operators in disputed cases. The bill numbers are HR1094 for the House version and S459 for the Senate bill. ARRL will be coordinating a grassroots campaign to have members contact their congressional representatives for support.
